MOVECO

The objectives of the MOVECO project are improving the framework conditions and instruments of policy strategies to promote eco-innovations, implementation of circular economy, supporting smart and sustainable development, and reducing the gap between the Danube region countries. 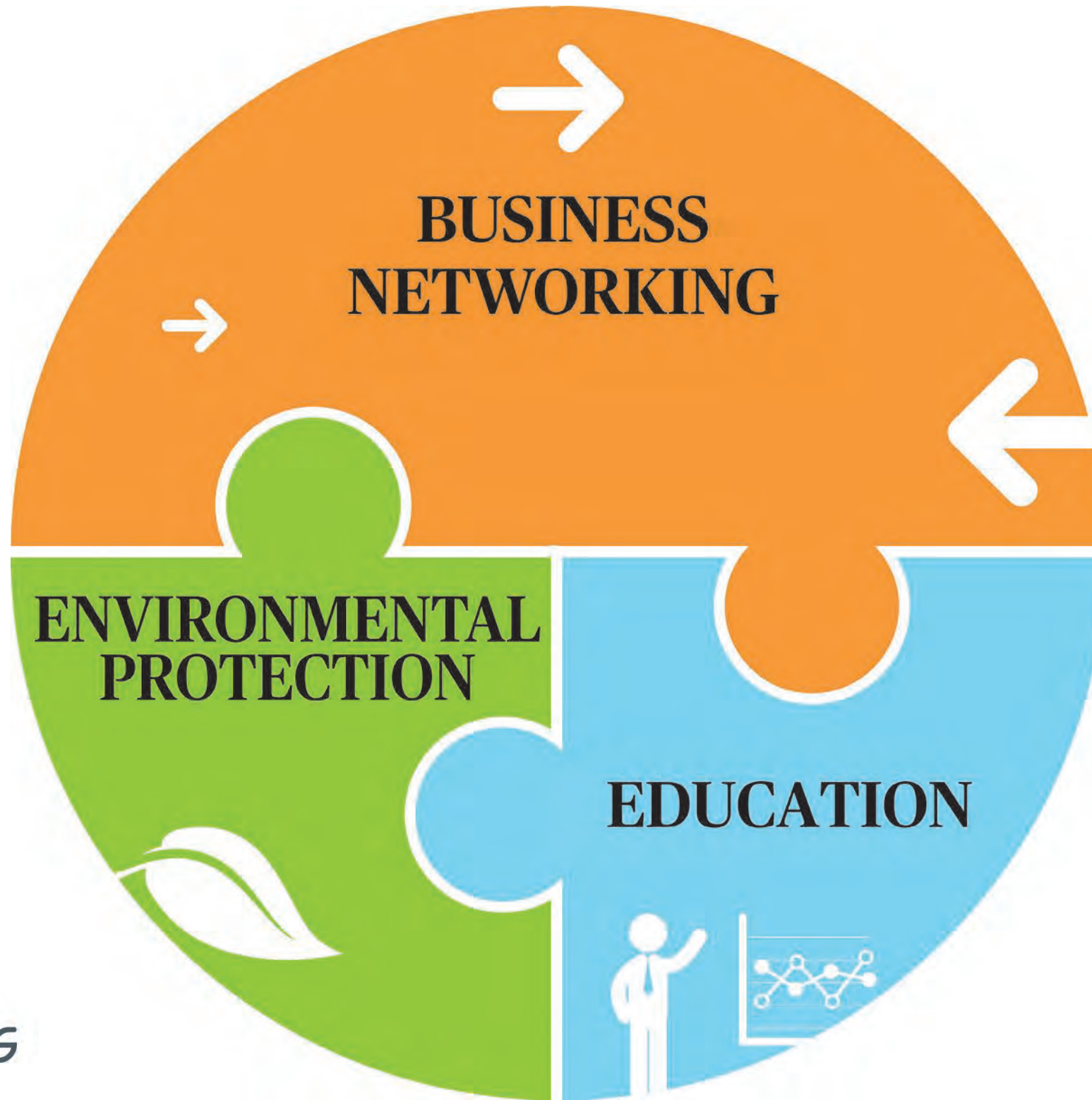
KET4CleanProduction

The KET4CleanProduction project aims to encourage advanced manufacturing technologies and related key enabling technologies in order to upgrade the production processes of SMEs towards resource, energy efficiency and sustainability. This is to be achieved in all the EU Member States by raising awareness of the potential of clean production innovations to increase the product quality, productivity and eco-efficiency, while also enhancing market share and competitiveness. In order to achieve this, the KET4CleanProduction aims to create one-stop-shop contact points for transnational access to innovative services for SMEs through a network of state of the art technology centres. The project is funded by the European Commission through Horizon 2020 programme.



ORGANIC BRIDGE

The ORGANIC BRIDGE project's objective is to connect the Osijek-Baranja County with the Southwest Bačka district by enhancing competitiveness through development of new and/or improved existing products, services and trademarks in organic production. This project aims to increase competitiveness and strengthen the cooperation of organic producers, associations, local authorities, support institutions, clusters, and educational and research organisations. In order to increase competitiveness, competence centres are planned to be established in Valpovo and Selenča to provide customised services and training. These centres are considered critical in improving the market position of organic producers of both regions, who want to increase the number of trademarks and improve development of conditions for the organisation of common retail chains by establishing the ecological network. The project is co-funded by the European Union through Interreg, programme for transnational cooperation Croatia-Serbia.

Erasmus for Young Entrepreneurs - PRACTYCE IV



Erasmus for Young Entrepreneurs is a cross-border exchange programme that gives new or aspiring entrepreneurs an opportunity to learn from more experienced entrepreneurs that are running smaller companies in other Participant Countries. The exchange of knowledge takes place during a stay with an experienced entrepreneur that helps the new entrepreneur acquire the skills needed to run a company. The host benefits from fresh perspectives on his/her business and gets an opportunity to cooperate with foreign partners.

The programme was initiated in 2008, when it already achieved remarkable results in young entrepreneurs' training under the mentorship of experienced entrepreneurs in the EU. Successful implementation, in which TERA Tehnopolis is involved within the framework programme, continues in the 7th cycle, which achieved two-year goals in less than a year. The project is funded by the European Commission through Erasmus for Young Entrepreneurs Programme. ENTERPRISE EUROPE NETWORK

Enterprise Europe Network was created by the European Commission as an initiative for supporting small and medium enterprises in creating conditions for business expansion in the European market, launching their own products/services or transfer of technology from abroad, and it is available to entrepreneurs free of charge. Collaboration is possible in both directions by launching products/services on foreign markets and identifying products/services for import. Some of the services available within the framework of the EEN are: information on supply and demand of products/services on domestic and the EU market; connecting to a network of consultants and researchers from different fields of science; identifying partners interested in transfer of technology; legal and advisory support in negotiations; protection of Industrial Property and the interests of entrepreneurs in the process of technology transfer; support in preparing project applications for EU funding; and similar. In order for EEN's support to entrepreneurs to be in accordance with the business on the common European market, there is a need for further development of businesses regarding intellectual property protection. Sectoral and thematic groups have been organised within the framework of the network, as well as EEN IPR Helpdesk Ambassadors programme that provides the clients with quality and reliable consulting and education on intellectual property protection in their mother tongue. Besides TERA Tehnopolis, Croatian regional EEN partners are: Croatian Agency for Small Business, Innovations and Investment - HAMAG-BICRO; Technology Park Varaždin - TPV; Science and Technology Park of the University of Rijeka - StepRi; Office of Technology Transfer of the University of Split - UTT Split; while the main coordinator of the Network is the Croatian Chamber of Economy. KEY ACCOUNT MANAGEMENT - KAM

The Key Account Management (KAM) project offers its services to innovative firms and firms with export potential. In order to procure these services, the firms are required to apply their projects within the framework of the Horizon 2020 programme. The services implemented in the first phase of the project are: detailed analysis and assessment of the user's capacity for innovation management, analysis of the user's request for support regarding their delivery success or an innovation project utilisation; identifying potential and suitable trainers from the central base; and setting up measurable key points that are going to support successful project implementation and build sustainable internal capacity for SMEs. The project is funded by the European Commission through Horizon 2020 programme.

SCALE-UP

The Scale-Up project provides support in business improvement to young and innovative companies that have a potential for growth and expansion on new markets. The programme's objectives are business internationalisation and accelerated growth, as well as increased profitability. The project is co-funded by the European Commission through COSME programme.

I-DARE

A cross-border region – where rivers connect, not divide

The I-DARE project (dual training development and introduction of tertiary systems in mechanical and electrical engineering) is implemented within the framework of Interreg V-A Hungary Croatia Cooperation Programme 2014 - 2020 (European Regional Development Fund). The project's objective is to develop dual training and introduce tertiary education systems in the field of mechanical and electrical engineering. The project aims to reduce general unemployment and youth unemployment by encouraging entrepreneurship and conducting training for helping young people in developing skills required for starting their own business. Since companies providing the transfer of

knowledge are also going to be involved in this project, participants will have an opportunity to gain practical knowledge. In addition, the project will also conduct trainings in business plan writing and financial and business skills development. The methodology that will be used in education of trainers and participants in the field of mechanical and electrical engineering is based on the methodology defined in the university textbook "Innovative3 Entrepreneurship", which is used in the business plan writing competition, Be the Role Model™. This approach proved to be extremely successful in practice, considering that more than 1500 students participated in the competition over a period of 13 years.



E-BUSINESS INCUBATOR TERA



This year TERA Tehnopolis signed a co-funding agreement on the E-business incubator project, through a business infrastructure development programme. The project's main objective is to improve incubation and consulting services through improving the quality of the business premises that TERA offers to entrepreneurs, located at Trg Ljudevita Gaja 6, and through development of software tools that are going to serve as a basis for further consultant work with entrepreneurs. TERA has evolved into an institution that supports innovative entrepreneurs. It acts as a technology transfer centre at the University and a regional office for technology transfer, certified by the Croatian Agency for Small Business, Innovations and

Investment - HAMAG-BICRO as a business and innovation centre and a technology incubator. That is why we aspire to follow international trends and, according to criteria no. 3 and no. 4 of the business incubator, develop a generation that emphasises networking, online incubation and online services, by offering access to technological, business and financial networks, as well as by supporting the international development of our tenants and clients. Service digitalisation is planned to be expanded on the whole region by involving local business support organisations in offering specialised services and establishing a connection with the research sector. The total value of this project, HRK 2, 492, 875. 90, is co-funded by the European Union from the European Regional Development Fund in the amount of HRK 1, 946, 686. 79.
