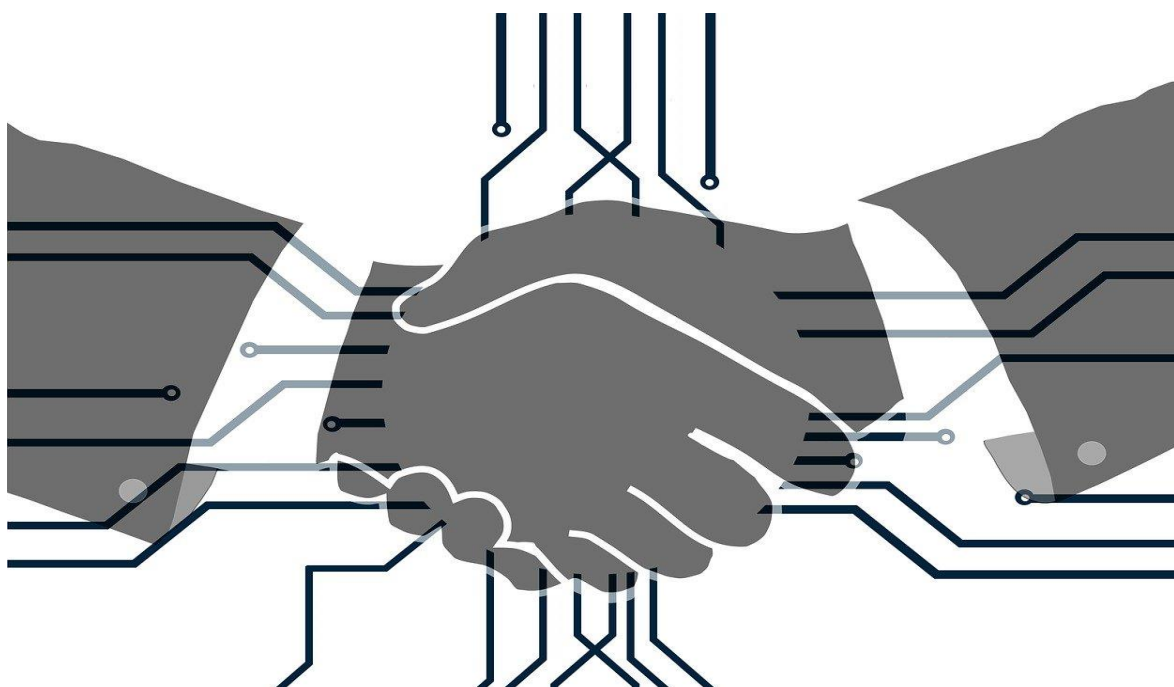

SME SERVICE 4: TRAINING PROGRAM FOR RTOS (FROM INVENTION TO THE MARKET)



GOALS: to train the technical staff to bring inventions out of the laboratory to the market. For this reason, the SKAPs will offer different services to the RTOs.

In addition, mentoring for specific topics may be performed from one RTO to another noncompeting RTO. The training program will be divided into three modules: market discovery, business modelling, investment readiness.

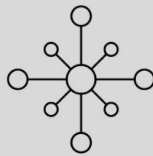
